HEIR, in collaboration with AI4HealthSec and Sentinel, proudly hosted the International Workshop on Information & Operational Technology (IT & OT) Security Systems (IOSec 2022) that was held in conjunction with the 17th International Conference on Availability, Reliability and Security. During the workshop, Prof. George Spanoudakis gave a keynote that reviewed the current state of practice and state of the art in the security of healthcare services.
